PRIVACY POLICY AND COOKIES POLICY

The purpose of the Privacy Policy and Cookies Policy is to explain the processes of processing your personal data by Marta Jaroch-Konwent and Agnieszka Pakos, partners of the limited partnership Jaroch-Konwent Pakos Kancelaria Radców Prawnych sp. k. (formerly: Jaroch Pakos Kancelaria Radców Prawnych s. c.), via the website wynajemwroclaw.pl (hereinafter referred to as the Website).

Personal data collected via the Website is processed in accordance with Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation, hereinafter GDPR) and the Act on the Protection of Personal Data of 10 May 2018 (Journal of Laws 2018, item 1000).

Data Controller

In connection with the use of the Website, your personal data may be collected via:

Purposes and Duration of Personal Data Processing

Providing data is voluntary but necessary to handle inquiries and provide services. Failure to provide data will result in the inability to respond.

Your personal data is processed to identify the sender and respond to your inquiries, requests, and to provide services. The legal basis for processing your personal data will therefore be:

- a) the pursuit of the Landlords' legitimate interests through communication with you and marketing their own services (Article 6(1)(f) GDPR), and in this respect, you have the right to object to the Landlords,
- b) the implementation of communication activities aimed at concluding a contract or performing an already concluded contract with you (Article 6(1)(b) GDPR).

You may also provide additional data that is not necessary to assist you but may be helpful, e.g., to facilitate contact. Providing such data is voluntary, and the legal basis for processing these data is your consent (Article 6(1)(a) GDPR).

Your personal data will be processed for no longer than is necessary for communication with you, until all activities related to the support provided to you or cooperation and limitation periods for

claims upon their completion based on the legitimate interests of the Law Firm (Article 6(1)(f) GDPR), objection in applicable cases. Furthermore, data will be processed until consent is withdrawn or the objection is accepted in applicable cases.

Data Recipients

The catalogue of recipients of Personal Data processed by the Landlords primarily results from the scope of services you use or your consent or legal provisions.

Partners of the Landlords may participate in processing Personal Data to a limited extent, in particular, providers of hosting or IT services, accountants, companies servicing software and supporting the Landlords in marketing campaigns, as well as providers of legal and advisory services.

Your data will not be transferred to an international organization.

While browsing the Website, information regarding your use of the Website is automatically collected, such as IP addresses based on access log analysis, e.g., browser type, operating system type, date and time of visits, number of connections, number of opened subpages of the Website, or the content you viewed.

The Website contains "Facebook", "Instagram", "LinkedIn", and "TikTok" buttons linked to the Landlords' accounts on social media platforms. By using these buttons, you log into the aforementioned services, which are subject to the privacy policy of the respective service.

Rights Related to Personal Data Processing

Stawki 2, 00-193 Warsaw) or the supervisory authority of another EU Member State, competent for your usual place of residence or work or place of the alleged violation.

We inform you that personal data collected in connection with the use of the Website will not be processed in the form of profiling.

Cookies

This website uses cookies. These are small text and numerical files saved by the IT system in your IT system such as a computer, phone, or other device from which you connect to the Website.

- a) session cookies, which are intended to collect information about your activities on the website and exist only during the session, which starts when you open the Website and ends when you close it,
